The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to participate in the second annual "Visions for the Future" Motorcycle Ride to benefit the Native American Rights Fund (hereinafter "THE RIDE" sponsored and/or conducted by Harley-Davidson, Inc., Harley-Davidson Motor Company, Bernie's Route 66 Motorcycles, Crossroads Cycles, Santa Fe Harley-Davidson and Sangre de Cristo H.O.G. Chapter, The Native American Rights Fund, Tribal Motorworks, Santa Fe Brewing Company, Ohkay Casino Resort and Hotel, San Juan Pueblo and their respective officers, directors, employees and agents (hereinafter, the "RELEASED PARTIES") releases and holds harmless the "RELEASED PARTIES" from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the "RELEASED PARTIES" in any way resulting from, arising out of, or in connection with the performance of their duties and my participation in any said **EVENT**.

I am voluntarily participating in the **EVENT** and I understand that this Release extends to any and all claims I have or later may have against the "RELEASED PARTIES" resulting from or arising out of their performance of their duties whether or not such claims result from negligence (except willful neglect) on the part of any or all of the "RELEASED PARTIES" with respect to the **EVENT** or with respect to the conditions, qualifications, instructions, rules or procedures under which the **EVENT** is conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE FOR MYSELF AND FOR MY SUCCESSORS, HEIRS AND ASSIGNS, NOT TO SUE ANY OR ALL OF THE "RELEASED PARTIES" AND TO INDEMNIFY, DEFEND AND HOLD HARMLESS ALL OF THE "RELEASED PARTIES" FROM ALL CLAIMS AND SUITS FOR ANY ACCIDENTS, PERSONAL INJURIES WHICH I MIGHT SUSTAIN TO MY PERSON, INCLUDING DEATH AND DAMAGE TO PROPERTY, CAUSED DIRECTLY OR INDIRECTLY BY ANY ACT OR OMISSION AND ANY NEGLIGENCE (EXCEPT WILLFUL NEGLIGENCE) ARISING FROM, OR IN CONNECTION WITH THE PERFORMANCE OF THEIR DUTIES IN SPONSORING, PLANNING OR CONDUCTING THE EVENT OR ARISING OUT OF MY PARTICIPATION IN THE EVENT.

I am experienced in and familiar with the operation of motorcycles and understand that motorcycle riding is inherently dangerous. Since I am voluntarily participating in this **EVENT**, I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the **EVENT**, and any negligence (except willful neglect) on the part of any or all of the "RELEASED PARTIES" in performing their chapter duties.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from any state statute which would negate or limit the scope of this release and Indemnification Agreement, including but not limited to Section 1542 of the California Civil Code which provides:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing this release, which if known to him must have materially affected his settlement with the debtor."
